### Eastern Delaware County Collaborative Stormwater Project

Chair Karen L. Holm is leading Council efforts to assist over **ten (10) urban municipalities** in Eastern Delaware County in their efforts to jointly address storm-water management requirements. By working together the municipalities are seeking ways to reduce their individual costs while still meeting state law requirements. The project is being funded by a **\$273,180** EPA Agreement. In late November 2009, The William Penn Foundation awarded additional funding of **\$198,000** to continue work on the project.

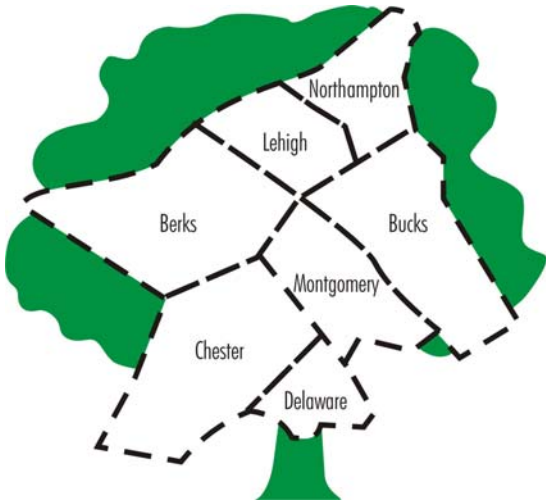

## Under 21 Business/Entrepreneur Seminar

Director Art Lukoff lead Council efforts to offer workshops for high school students in Lehigh County to learn about starting a business and/or being an entrepreneur. Frank Embon, SCORE volunteer, taught the students about marketing, and accurate record-keeping. Mike McCreary, a young entrepreneur in his 20s, spoke to the students about his experiences as a business owner. **Over 200 students benefited** from the project and approximately **20% of the students were socially and/or economically disadvantaged individuals.**

### Council Donation

In 2009 the Council **donated** horse-drawn no-till planting equipment valued at approximately **\$8,000** to the Chester County Conservation District for use by Amish farmers to plant their farm crops. This will help protect farm fields and the watershed from soil erosion.

### Board of Directors Training

To continue building the Board of Directors knowledge and skills, **three training workshops were held.** The Directors learned about nonprofit financial management, nonprofit best management practices, and nonprofit fundraising. They also heard a presentation by USDA-Rural Development about their programs.
